

## KRTC's Trip to the Virginia Creeper

Sixteen people made the Kentucky Rails to Trails Council trip to the Virginia Creeper Trail near Abingdon, Virginia on October 21, 2006. The Virginia Creeper Trail is a 33 mile public access, shared-use trail connecting Abingdon, Virginia with the Virginia-North Carolina Border. The railroad was abandoned in 1977 and in the early 80's the ROW was purchased with bridges and trestles intact. Half of the trail is owned by the federal government as part of the Mt. Rogers National Recreational Area and half by local towns around the trail.

Damascus while others only did the segment from Damascus to Abingdon. However, a few brave souls did the entire 33 miles! "No matter which part of the trail we took, we all enjoyed the ride. In fact, we are already thinking about when we will be going back to ride the trail again."

Tourist use of the Creeper trail started to significantly increase in 1995. They now estimate that 200,000 to 250,000 tourists come through Damascus yearly because of the trail. They now have 5 bike rentals in the town and extra vans for shuttles are

rented by the shops during peak weekends in the fall. Like most railtrails there is no fee to ride or walk the Virginia Creeper. The town recoups financially from hosting the trail by having a 5% "meals and lodging" tax inside the town limits. The tax base of the town has also increased since the trail was opened and this rise is attributed to the increased attractiveness of the town to businesses due to the economic impact of the trail and higher residential real estate values.

On October 21, 2006, The Little Mount Trail Commission, Inc visited the Little Miami Scenic Trail on an absolutely gorgeous Saturday!

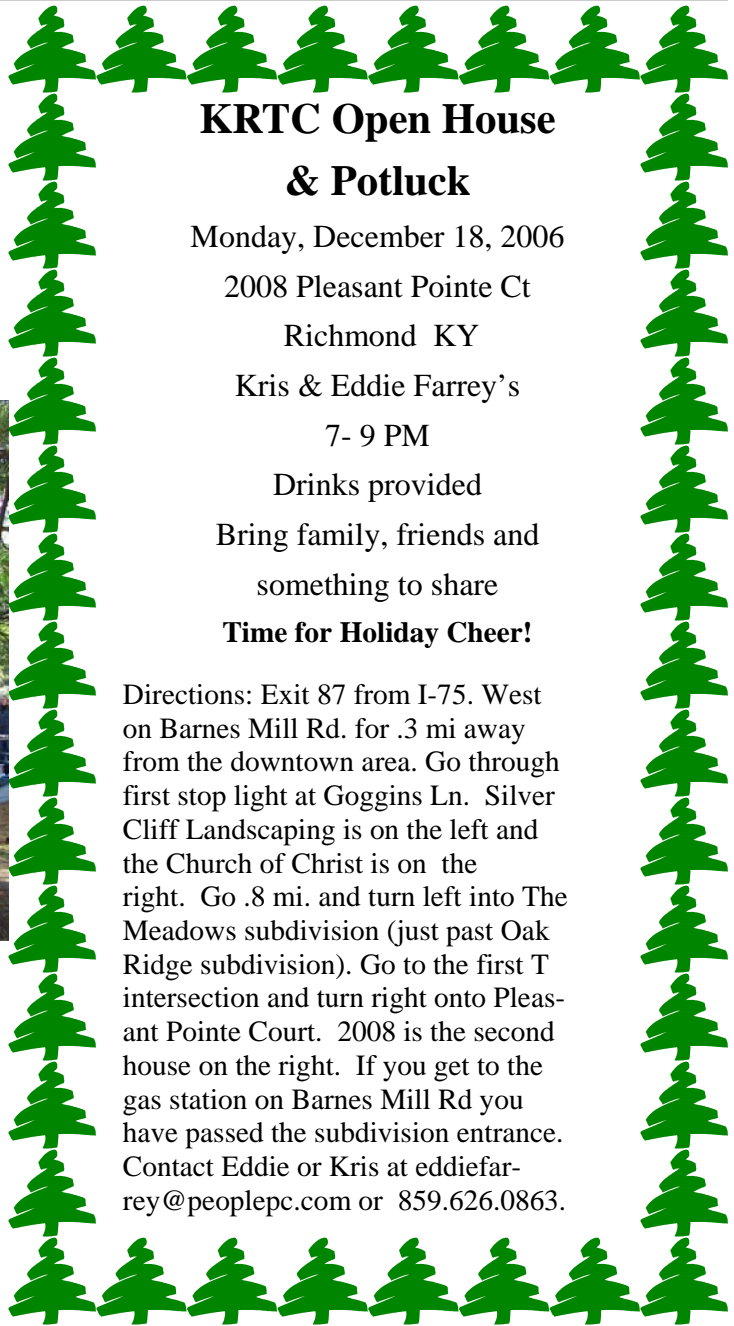

The eleven mile road ride was held to attract new and beginning riders, to promote the local 1.5 mile rail trail, to stir interest in community involvement for the expansion of this trail and to raise awareness about other trails in Kentucky as well as neighboring states. We accomplished all these goals, including the inspiration for PAC to join KRTC as a Member Organization. Par-

The KRTC table display at the White Plains Senior/Community Center was the centerpiece of the event. Participants were impressed with its size and the information it provided. Everyone was surprised at how many rail trail miles are possible in

"I think it's a shame that Kentucky has such a large untapped resource with all the abandoned rail lines. It seems to me that more people would want these to be opened up and improved for the enjoyment of the public," said Brad Rose of Nortonville.

White Plains Mayor, Ronnie Lewis, spoke of the need for community leaders to envision a higher quality of life that a rail trail can bring to a community. He was instrumental in securing the trail as well as the newly opened Senior/Community Center adjacent to the trail. The trail is adorned with an old caboose, large boulders and benches for resting and adds a warm welcome to the little town of White Plains.

## Student restoration of Mt. Sterling's C & O Depot

The C&O Train Depot in Mount Sterling, Kentucky will have a restored new look thanks to extraordinary students at the Montgomery County Area Technology Center.

School clubs, Future Business Leaders of America and SkillsUSA students have teamed up to restore what will become the Mount Sterling Trailhead along the proposed Lexington Big Sandy Rail Trail.

The students have successfully applied through the City of Mount Sterling and secured \$153,000 through Kentucky State Transportation Enhancement Funds for their remarkable community service project. These students will be completely hands on in the restoration of the structure to its original honor, beauty, and prestige throughout the next three years.

The C&O Train depot is on the National and State Registry of Historic Buildings. Once completed the attraction will house a community multi-purpose meeting room and a train museum.

## Rail Trail in Pulaski County

In September Keith Lovan from KRTC and Brent Sweger from the Transportation Department met with Joel Zimmer, Alex Godsey, and Mark Travis, representatives from the Lake Cumberland Trail Foundation to discuss the expansion of the Cathy Crockett Rail Trail in Pulaski County. Based upon a study done by John L. Carman and Associates the trail has another 8 miles of potential. The study recommended new trail construction and improving the existing railbed. It also recommended improvements at Alpine Coal Camp and Camp Greenwood.

Alex Godsey said that there was some funding available from the Transportation and Community and System Preservation Pilot Program (TCSP). He thinks he could clear some of the existing vegetation to make it suitable for hiking/walking and maybe even mountain biking. Recognizing that it would not be enough money to construct the entire corridor he felt that if he could get enough area cleared and show the citizens of Pulaski County what could be done then he could get more support for more funding to complete the entire trail.

Joel, Mark and Alex were going to meet with local contractors and local city and county officials to see if they could get the project moving again. They feel with the influx of new residents to the community that are looking for more facilities like rail trails then this is the most logical place to start.
